The goal of the project is to actively involve the local communities in conservation efforts, through the creation of buffers to the National Parks, giving them control over the conservation which directly affects them, whilst also incorporating livelihood improvements such as job opportunities, a long term and sustainable revenue stream to enhance community ownership and food security through HWC mitigation.
